1. PURPOSE

The parties agree to collaborate on a Time For Photos ("TFP") basis for the purpose of portfolio development, professional experience, networking, and promotional use. No financial compensation shall be owed by either party unless otherwise agreed to in writing.

2. DELIVERABLES

The Photographer agrees to provide the Model with:

Images will be delivered within _____ days of the shoot date unless otherwise agreed in writing. The Photographer shall determine the final selection of images to be edited and delivered.

3. **COPYRIGHT:** The Photographer retains full copyright ownership of all images created during the collaboration unless otherwise agreed to in writing. Nothing in this Agreement transfers copyright ownership from the Photographer to the Model.

4. **MODEL USAGE RIGHTS:** The Photographer grants the Model a non-exclusive, perpetual license to use the delivered images for:

- Personal portfolio
- Casting submissions
- Agency profiles

- Comp cards
- Personal websites
- Social media
- Self-promotion
- Other_____

The Model may not sell the images, license the images to third parties, or use the images for commercial advertising purposes without written permission from the Photographer.

5. PHOTOGRAPHER USAGE RIGHTS: The Model grants the Photographer permission to use the images for:

- Portfolio display
- Website content
- Social media
- Studio marketing
- Competitions and publications
- Self-promotion
- Other_____

The Photographer shall not sell the Model's likeness for commercial advertising campaigns without obtaining any required releases or permissions.

6. CREDIT: When reasonably possible, both parties agree to credit one another when posting images online. Both parties agree to credit and tag one another when posting images online or on social media platforms, unless otherwise agreed in writing.

7. IMAGE ALTERATION: The Model shall not apply filters, excessive retouching, AI alterations, or other modifications that materially change the Photographer's work without prior consent. The Photographer shall not materially alter, manipulate, generate, or recreate the Model's appearance through AI or other digital technologies for commercial use, advertising, marketing, endorsements, stock photography, or third-party distribution without the Model's prior written consent. Cropping and resizing, black and white conversions, for social media, websites, and portfolio use are permitted.

8. CONDUCT AND SAFETY: Both parties agree to maintain a respectful, professional, and harassment-free environment. The Model may decline any pose, wardrobe, concept, physical contact, or activity that causes discomfort. The Photographer may discontinue the session if unsafe, inappropriate, or disruptive behaviour occurs.

9. CANCELLATION: Either party may cancel the collaboration at any time. Whenever possible, at least 24 hours' notice should be provided. Neither party shall be entitled to

compensation, damages, or reimbursement arising from the cancellation of a TFP collaboration.

10. LIABILITY: Each party participates voluntarily and assumes responsibility for their own actions, property, transportation, and personal well-being. Neither party shall be liable for indirect, incidental, or consequential damages arising from participation in the collaboration except where prohibited by law.

11. NO EMPLOYMENT RELATIONSHIP: Nothing in this Agreement creates an employment relationship, partnership, agency relationship, or joint venture between the parties.

This Agreement represents the entire understanding between the parties regarding this collaboration and supersedes all prior verbal or written discussions relating to the shoot.
